REPORTS AND COMMUNICATIONS

Office of the Mayor:

Mayor Casey stated we had a couple interesting weeks. The Hometown Tap, Pizza Plus, LaPlayita and VFW have all opened for outdoor seating, please support them. Everything is going fine, there is a new Alerts system the Chief will discuss later. Mayor Casey thanked the Hometown Fire Protection District and the Hometown Police Department for getting us through these difficult times.

Office of the City Clerk:

Clerk Hacker reported that her office received notification from the Department of Revenue that the Sales Tax collected in the month of February 2020 was in the amount of \$15,072.67 the amount collected in the month of February 2019 was in the amount of \$15,578.98.

Clerk Hacker reported that her office received notification from the Department of Transportation that the MFT collected in the month of February 2020 was in the amount of \$7,725.50 the amount collected in the month of February 2019 was in the amount of \$8,206.67.

Clerk Hacker reminded everyone that Vehicle Stickers are on sale and we are open to the public with one service window and wearing of masks.

Office of the Treasurer:

Treasurer Roti stated everyone should have a copy of the reports generated by his office. Everything is going well, as you can see we collected over \$30,000.00 in LDR to date.

REPORTS FROM CITY APPOINTED OFFICIAL

City Attorney: Michael Cainkar, City Attorney had no report.

Police: Louis Dominguez, Chief of Police reported it was a busy Sunday with protests. There was a page, text and email sent and we had extra staff very quickly, we had a minimum of five extra staff. We received a thank you from the Burbank Chief. We did respond to four incidents in other towns, one being shots fired in Oak Lawn. That started a conversation with Oak Lawn to have permission to monitor their police band; the Mayor was able to get movement on that. Chief Dominguez stated he started updating Face Book to dispel rumors. There is a new messaging system we are currently putting in place and we will have something in the Hi-Lites regarding the sign up procedure. We have put in place a rifle policy, we have nine officers qualified and the rifles have been deployed. One of our officers put together a blood drive and it went well, we collected 23 pints and due to Covid and social distancing, we had to turn people away.

Mayor Casey stated as you can imagine, the Chief has been here many hours beyond his usual hours, he was the first on the scene for the Oak Lawn shots fired call, he leads by example and he is currently leading a top notch department.

Public Works: Mark Trlak, Director not present.

Building James Forbes, Building Commissioner had no report.

Public Health and Safety: Bonnie Gesiakowski reported she has left many notes regarding garbage cans being out past the time stated in our code. Director Gesiakowski stated she felt the dumpsters were a great idea, many people have cleaned up and most people are complying after receiving notes.
