Legislation: Alderman Beyer reported they passed the budget June 1, 2021 in Springfield and they reserved the LDGF. They increased the non- home rule municipalities charge per gaming machine from \$25.00 to \$250.00 per year. Mayor Casey stated they increased the amount of Cannabis Licenses from 75 to 150, this bill has not been signed by the Governor yet.

Fire Department: Alderman Rick Banasiak reported they will meet next week. The Mayor will talk to them about the trailer blocking the sidewalk.

Personnel Review: Mayor Kevin Casey, Chairman had no report. Chief Dominguez had no report. Alderman Beyer had no report.
